

SAVE A LIFE - DONATE FOR A CRITICAL SURGERY EXPENSE

PROFILE :

We, P. Natarajan and M. Chitra Devi are the parents of our only son **N. DINESH**, aged 35 years. He was born on 10.06.1987 at Christian Mission Hospital, Madurai.

He was born with Anorectal Anamoly which is the root cause of all his illness till now. We put in school when he was 4 years. He was very good in his studies. But he developed inferiority complex because of his health condition. Even then, up to IX Standard, he pursued his studies well, amidst all his health issues. After that he fell ill seriously, that he could not continue his studies in schools. He stayed at home struggling with his illness but out of his own interest in studies, he completed the X, XI & XII Standard privately in a successful manner.

Since, that time, allopathy did not help us to recover my son from his illness; we shifted his medication to siddha, ayurvedic then to homeopathy and in the last to Naturopathy. In the start of every alternate medication, there would be some improvement in his health. But as days passed, that medication will also not help; instead will make his health more badly. Days passed this way with all struggles to survive until he was 24 years. He was slowly counting his last days and we, as parents were left helpless to save our son.

Again, when we moved to allopathy and took him to various reputed hospitals in Madurai, Chennai and Vellore, none of the doctors gave us any positive word for our son to survive in this world. The doctors whoever we consulted with hope, on seeing our son's health condition, ended with only a negative statement that our son would live only for few days / years and that he is in his last stage of chronic kidney disease – which could not be treated because of his past medical history where he had already undergone many surgeries. On hearing these words from medical experts, we, the desperate and helpless parents did not know what to be done. We left our son in the hands of the Almighty, pushing the time sitting beside his bed all days and nights and praying to god to show us a path to save our son.

On 20th December 2010, we received a phone call from one of our relation, who is a resident of Coimbatore. He insisted us to consult a doctor named Dr. M. RAMALINGAM (**Dr. MR**) who takes up challenging cases and succeeds in it. We thought of taking up this as the last chance, to save our son and moved to Coimbatore to consult Dr. MR.

We gave DR. MR, all of our son's medical reports which helped him to study about our son's past health conditions and the 5 surgeries our son had undergone till then. Dr. MR took a week to diagnose in all ways and means to find out a solution for our son's ill health. After a week, Dr. MR approached us positively and gave assurance to save our son from his illness. From that time onwards within the next 8 months Dr. MR gave our son a new life. Our son was again born at the age of 24 years as a hale and healthy person on August 15th 2011, the day on which the kidney transplant surgery was done for our son. His Father P. Natarajan, was the kidney donor.

From then onwards, our son was in the full medical guidance and care under Dr. MR. We, as a family with our son spent our days happily. Our son completed his B.Sc., degree in Animation. He got a job in an MNC company – BOTT VFX, where he proved his talents and was seen special and different in all the works he did. As days passed peacefully, during March 2019, suddenly he fell ill again. Dr. MR after diagnosing him told that his transplanted kidney failed to work. This left us in panic and the world again seemed to be dark and we were heart broken. From March 2019, our son is in Hemodialysis and till now undergoing a serious health issues day by day in all ways. We are living each day with great financial problems and great mental struggle along with our own physical ailments.

P. NATARAJAN, Father of N. DINESH, a B.Com graduate, aged 62 Years, was working in a private book publishing company in Chennai till 2010 with a monthly salary of Rs. 20,000 at the time. He left the job in December 2010, since he had to donate one of this kidney to our son. After the kidney transplant surgery, he could not go for work. But, he took care of our son fully being at home. M. Chitra Devi, Mother of N. DINESH, aged 59 Years, is working in a government concern as a 'C' class employee, receiving a meager amount as salary at the end of each month which itself is not self-sufficient. 80% of the salary amount is spent for our son's medication every month and we are undergoing great hardships to survive in this world.

OVERVIEW OF OUR SON'S MEDICAL CONDITION

From, his birth on 10.06.1987 to till date, our son has undergone 12 surgeries. They are as follows..

1. Transverse Colostomy on 11.06.1987 at the age of 01 Day.
2. Posterior Sagittal Anorectal Plasty on 25.03.1988 at the age of 09 Months.
3. Colostomy Closure on 19.07.1988 at the age of 01 Year 01 Month.
4. Left Ureteric Re-implantation on 15.11.1988 at the age of 01 Year 05 Months
5. Right Ureteric Re-implantation on 28.12.1989 at the age of 02 Years 06 Months.
6. Urine Bladder Augmentation on 15.02.2011 at the age of 24 Years 08 Months.
7. Renal Transplant on 15.08.2011 at the age of 25 Years 02 Months.
8. Right Lap Nephrectomy on 16.12.2015 at the age of 29 Years 06 Months.
9. AV Fistula on 17.04.2019 at the age of 32 Years 10 Months.
10. BVT on 13.06.2019 at the age of 33 Years.
11. Johansson Stage – I Urethroplasty on 04.09.2019 at the age of 33 Years 03 Months.
12. Laparotomy with Hernioplasty on 05.10.2022 at the age of 35 Years 04 Months.

At present, our 35 years old son, is idle at home passing his days with lots of illness in his body such as indigestion, Blood Pressure variations, sleepless nights, heart problems, loss of appetite, loss of body weight, body and joint pains, burning sensations in throat, chest and stomach, undergoing the deadly procedure of Hemodialysis, twice a week and above all the mental worries for him and for us, as parents, seeing our son's struggle and pain, all day and night. Our son has lived his life healthy and happily only for about 8 years, out of his 35 years of survival. Those 8 years were from August 2011, after his first kidney transplant up to February 2019.

We started our life happily in 1986 with few assets and savings. DINESH.
